TUITION AGREEMENT FOR THE LIBERTY SCHOOL: 2011-2012

We are pleased that you have enrolled your child in The Liberty School for the 2011-2012. The Staff will work hard to ensure that the experience will be a challenging, successful, and exciting one for your child.

Tuition for the 2011 - 2012 school year is \$11,900. Please read this Tuition Agreement carefully. There are three payment options. (see attached). Indicate the one you choose. Please note: whichever payment option you choose, payment is due either by May 15 or September 1, 2011, and the beginning of each payment period thereafter. There is no refund or reduction in tuition given due to absences, vacations, holidays, or snow days during the school year.

The Liberty School's cost commitments are predicated on a certain number of students for the entire year. In the event of absence, withdrawal, or dismissal of your child at any time during the school year, please understand that you will still be responsible for full payment of tuition, and no adjustment thereof will be made. The fact that The Liberty School allows tuition to be paid quarterly does not create a fractional contract or in any way relieve the Responsible Party of payment for the entire year's tuition.

Please sign this agreement and return it along with a \$1000 non-refundable deposit, applicable towards the full tuition.

The undersigned shall pay interest on overdue amounts at the rate of 18% per annum. The Responsible Party assumes responsibility for all fees (administrative, attorney, court, etc.) that might result from action by The Liberty School involving said Responsible Party.
